I hope that the September issue will not be too long delayed.

## IN THIS ISSUE

This number contains rather more administrative matter than is usual. However the financial affairs of the Circle are important and members owe a debt of gratitude to Robin Bertram, Steven Bunce and John Sears for their hard work in managing and presenting the various accounts. The sums of money are considerable and increasing. In addition to the regular items in the Secretary's report there is a review of the late Themis Dacos' book on the early Greek Consular Services in Egypt.

It is hoped that the Chairman's comments on The Studies will help to renew team research within the Circle. There is a list of members with particular special interests. I hope to write about Studies, Study Leaders and the QC in a forthcoming issue.

Peter Smith reviews the literature and his research on the 3m and 10m postal cards of pictorial design. There are items of interest to Hotel enthusiasts including Lucien Toutonji's report of a seemingly unrecorded modern conference postmark of the Nile Hilton hotel. John Sears seeks information about the 210m 1st Fuad stamp booklet. Other items include further reports of the postal stationery variety reported by Peter Andrews, Dutch shipping line cancellations, Army Post control blocks and questions about an intaglio seal and a modern exchange control mark - something of interest for everyone I hope.

#### BOOK REVIEW

## CONSULAR IN EGYPT by Themis Dacos. 117pp £27.50 inc. postage and packing. Obtainable from James Bendon Ltd., PO Box 6484, Limassol, Cyprus.

Just before he died, Themis Dacos (ESC 220) completed his book, Consular in Egypt. This traces the history of the Greek Community and its Consular services in Egypt. It is printed on alternate pages in Greek and English and is well illustrated in the text with 8 pages in colour showing covers and Consular adhesives. There are 2 maps which may be a little too detailed for clarity.

The book is of A4 size and is printed on good quality shiny paper. It is divided into three sections, the first of which is by far the longest and is of most interest to students of Egypt Postal History.

Part 1 traces the history of the Greek people in Egypt from the early part of the 19th Century until the present time. It deals with their distribution in the various towns and provinces, and the establishment of Consular facilities. Consular duties are examined and Offices are listed with their dates of origin and organisation. The Bibliography shows that much of the information is taken from Greek official sources. This section also deals with Consular correspondence. Covers are illustrated and rates explained. It seems that "Official" mail inside Egypt was carried post free but that extra services like Registration had to be paid for at the current rate. Any mail sent abroad was charged at full current rates.

Part 2 deals with the handstamps used formally to identify documents, correspondence and forms. This is a well illustrated section giving precise dimensions and listing dates of usage of the various types.

Part 3 is devoted to the use of Consular adhesive stamps, all of which had a value in Greek currency (lepta and drachma). Six issues are listed and illustrated. Notes on their use are provided. One imagines that these items fall within a 'Cinderella' category.

In his Preface dated March 1993, Themis explains the difficulties involved in writing on a subject not fully documented over the years, and one which is not very fashionable philatelically. He admits that there may be gaps. Nevertheless he is to be congratulated on having provided good readable information which has not previously been available. What a shame he is no longer with us.

I am sure that Themis would have welcomed comments. Anyone who has additional information might like to communicate with the Editor of the Quarterly Circular.

THE CALENDAR OF THE OTTOMAN EMPIRE by Dr. Andreas Birken. 40 pp; card cover. £6.00, DM15, \$10.00. Obtainable from James Bendon Ltd., PO Box 6484, 3307 Limassol, Cyprus.

This is the first of a planned series of monographs that will cover many aspects of the philately and postal history of the Ottoman Empire and the Republic of Turkey. The introductory section describes the different calendars used in the Ottoman Empire and is followed by 27 pages of tables that will assist postal historians in identifying and converting dates in cancellations. The series is published by the Arbeitsgemeinschaft Osmanisches Reich/Turkei (Ottomon Empire/Turkey Study Circle) in Germany. Bilingual German and English. 1995.

Dr. Andreas Birken (ESC 416) has donated a copy of this monograph to the Library. He writes:- "I have read with some amusement the decision to abandon "The Book". This problem is not at all peculiar to the ESC. The "Arbeitsgemeinschaft Osmanisches Reich/Turkei" has been trying too but at the moment no second author is in sight! Editor.

#### THE STUDIES

It will be just as important to advise matters which they are unable to resolve to the Editor so that the problem may be referred to the membership as a whole.

I feel that it is also important to monitor progress. I would be very grateful if those named would let me know by the end of 1995 what progress is being made.

If any member has interests not mentioned in the list, please advise the Editor so that it can be recorded in a future issue.

This is an exercise in participation by everyone. Please cooperate so that the study groups can be vigorous and enterprising centres of research.

## THE PICTORIAL 3m and 10m POSTAL CARDS

## Peter A.S. Smith (ESC 74)

It was nearly three years ago that Anton Jansen<sup>1</sup> asked about a 3m. orange postal card in the Ras el Tin Palace design with altered inscriptions, and five years ago that Charles Hass<sup>2</sup> illustrated two types of the 10m. postal card in the Colossi of Memnon design. A response to those interesting reports is long overdue.

Let us start with the literature. Both of these items were recorded 59 years ago (sic!) by the late Jean Boulad,<sup>3</sup> although without accurate dates. He illustrated the scarce second type of the 10m., but the numbers assigned to the illustrations were unfortunately scrambled. The Higgins and Gage catalogue<sup>4</sup> listed both types of the 10m., but missed the second version of the 3m. Their list, including the majority of the illustrations, was made up largely from my collection, and at that time I did not have the second type. Both types of each value were also listed by Albani and Zeitoun, albeit without illustration.<sup>5</sup> There should therefore never have been doubts about the second type of the 10m., but doubt about the second type of 3m. is understandable, since the two references in which it is described are not easily accessible nowadays.

The two types of the 3m. differ only in the typefaces of the English and Arabic texts (fig. 1). The measurements have been recorded in the QC, but it is worth stating explicitly that the Arabic texts are identical except for the style of lettering.



The two types of the 10m. are another matter. It is not so much a difference in the lettering as in the actual words. In the original type (1923), the country name is given as quty ('dominion' or 'country'), and the equivalent of CARTE POSTALE is given as tizkara posta, whereas in the second type (?1931), the words are dawla and tizkara barid, respectively. Thus the older words have been replaced by those also used on the adhesive stamps of the King Fuad era.

The original postal cards were printed by Thomas de la Rue & Co., who held the contract for printing all of the postal stationery for Egypt. However, the firm was informed by a letter dated December 20th, 1926, that its contract would not be renewed, but would be opened for "public adjudication". During 1927, the firm continued to fill orders while finishing off its commitments to Egypt. Meanwhile, the contract was given to Harrison & Sons who began work presumably in 1928. Part of the reason for the change of printers was dissatisfaction over the inability of de la Rue to produce an acceptable likeness of King Fuad for use on postal stationery; it is evident from the correspondence in the de la Rue archives in the National Postal Museum, London, that the Egyptian Government was very anxious to have its postal stationery as well as its stamps show the likeness of the King, and was becoming exasperated with de la Rue's unsatisfactory efforts.

When de la Rue's work was finished, the various dies, which were the property of Egypt, were turned over to a Government They were therefore available for loan to representative. Harrison's, the Survey Department, or any other printer of the Government's choice. The dandy-rolls for making watermarked paper were also Egyptian property. They remained physically with the paper maker, but control of them was turned over to Harrison's, who presumably used paper made with them in the manufacture of envelopes and letter-envelopes. From these facts we can see that the second types of the two postal cards, which, as far as we can tell were not issued until 1930 or later, could not have been printed by de la Rue. Furthermore, there is nothing in the de la Rue correspondence relating to a change in the texts of the postal cards. I suggest that both were printed by the Survey Department as a stop-gap measure while others showing the King's portrait were being prepared. However I cannot rule out the possibility that Harrison's printed one or both.

The dies for the impressed stamps would not have included the postal card texts. Therefore, these would have been made up anew by Harrison's or the Survey Department. If Harrison's did the work, they would most probably have used an existing de la Rue card as a model, and would not have made such major changes in the style or wording as took place, unless they were given specific instructions. The Survey Department, however, being well versed in the niceties of Arabic calligraphy and printing, could have used its own judgement as to the choices. Since the 3m. continued to use the old words in the text, it was probably produced first, to meet a pressing demand. When it came to the 10m. there was apparently time to change the Arabic wording to conform to the contemporary preferences. In this connection it is worthy of note that the 3m. green postal card in the same design, believed to have been issued in 1931, not only uses barid as does the second type of the 10m., but also uses French instead of English.

As for dates of issue, I have seen the second type of the 3m. with

postmarks of October and December, 1931, and one dated April, probably 1931 (courtesy of Peter Feltus); these are earlier than the date reported by Jansen ("16 MA 32"). Since the green 3m. is believed to have been issued in 1931, the date of the orange one is probably no later than 1930. I have a second type 10m. used "24.2.33", up-rated with a 3m. stamp for the increased rate to Germany, and Hass has reported March, 1932. A plausible date for its issue would be in 1931.

Another elusive postal card is the 3m. orange reply card with the words 'response', 'avec reponse', and the Arabic equivalents obliterated with two parallel thin lines, purportedly in 1931. These (ie the two separated halves) are listed in Higgins & Gage and by Albani and Zeitoun, but not by Boulad. They are, I believe, rarer than the second types of the 3m. and 10m. just discussed. I have seen only a single example of one half, and until I found it, I had begun to wonder whether it really existed. There is a lesson in all of this: if something is recorded by a reputable source, it is not wise to doubt its existence solely on the basis of never having seen an example!

I recently had a letter from our member Mrs. Lenora (Nonie) Green (ESC 433) requesting information about a cover which she had recently purchased.



This made me very excited. We are well aware of the three Aerial Post cachets which were in general use during the riots in Egypt in 1919 and which are illustrated below. Is this going to be a fourth?





So far, the last recorded usage of any of them is the 4th May, 1919 - this was one of those used in Alexandria - shown on the right.

On enquiry, Mrs. Green confirmed there were no markings on the back, and from the original, the date did appear to be 8.5.19 (8th May). It had been described by the London dealer selling it as "not previously recorded".

I then discussed the matter with John Revell (ESC 78). From his service in the R.A.F. he had painful memories of Amria which lies about 25 miles South West of Alexandria. He also told me that "T.D.S." stands for Training Depot Station.

The item is in fact shown in the book by John Firebrace (ESC 74) "British Empire Campaigns & Occupations in the Near East, 1914 - 1924", Page 445. Although the date does not appear in illustration, 8.5.19 is noted on page 443 as the only date recorded. I have spoken to Firebrace asking if he could recall the source of his information. He could say only that the cover had been lent to him by the same London dealer so it seems that Mrs. Green's cover is the same one. We discussed its possible usage and whether it could be added to the original 3 EEF cachets. One snag is that it is addressed to someone in Amria and the cachet was presumably applied there perhaps as an arrival mark. Or was it contrived by a philatelically obsessed Officer or Post Corporal -"If Cairo and Alexandria can have special cachets, why can't we?"

The date is very close to the Aerial Post service and this makes the item potentially very important and deserving of full enquiry. If any member can throw any light on the matter or has any background information of Amria or any other theory, please let us know without delay. It would be wonderful if someone could come up with another cover with the same cachet and around the same date.

## Cercle Khedivial

Since my original note and question on this subject (QC No. 169, June 1994, p.162) some new material has come to hand. I now have a cover identical to my previous 1888 one franked 2 x 5 mills and cancelled 16 IV 94 from Alexandria to Manchester (fig. 1). Thus these envelopes were in use for at least 6 years.

The second item bears a similar crest but is printed in blue and of much cruder appearance (fig. 2). It was also franked 2 x 5 mills and sent from Alexandria to Italy. The date of cancellation is unclear but it is dated 20.9.02 on receipt. This design may therefore have superseded the previous one.

A third cover bears 2 x 15 mills of the 1927 1st Fuad issue registered from Bab el Luq to France. This bears a printed crest in blue of the Club Mohamed Ali (fig. 3). Was this a change of name or a different club?

Finally I have an unused postcard (undated) depicting the "Club Khedivial" in Alexandria (fig. 4).

Clubs. Cercle Khédivial, on the first floor of the Exchange (Pl. F, 4), handsomely fitted up, patronized by Europeans of all nations; introduction by a member necessary; after a week visitors must purchase a ticket of admission. - Cercle Mohammed Ali, Rue de la Porte de Rosette 2, similar. -

In the 1929 edition the same entry has been modified as follows:-

Clubs. Sultan Hussein Club (formerly Cercle Khédivial), on the first floor of the Exchange (Pl. F 4), 2 Rue Chérif Pacha, frequented by Europeans of all nations; introduction by a member necessary; after a week visitors must purchase a subscription ticket. - Cercle Mohammed Ali, 2 Rue Fouad Premier, similar.

Thus the Cercle Khedivial and the Cercle Mohamed Ali were two different but similar clubs in Alexandria. The Cercle Khedivial became the Sultan Hussein Club at some time betwen 1914 and 1918 (see Eriksson, QC No. 170, Sep 1994, p.191). The Rue de la Porte de Rosette on which was located the Cercle Mohammed Ali was at some time renamed the Rue Fouad Premier. Editor

I have just finished sorting my collection of control blocks of the Army Post Stamps and it occurs to me that there may be some control block addicts (like myself) who would find some interest in a list of the differences between the controls on the two panes of these issues.

#### The Small Stamps

It is easy to identify the two panes from their perforations. The pane which I have christened Pane A has the perforations extending across the bottom margin. Pane B has the perforations across the right hand margin.

The whole lot was provisionally housed in an album and forgotten. Only after my retirement was the album unearthed and I became puzzled about the foreign postmarks on one of the covers. It reads POSTAGENT BATAVIA-ROTTERDAM and is dated 30 VII 35.



I consulted the Dutch Association of Aerophilatelists and below is the answer to my query. It may be of interest to other members.

Your query relates to the Batavia-Rotterdam mailing service.

This postmark is illustrated in 'Postmarks of the Dutch East Indies 1864-1950' by P.R. Bulterman, page 120.

On ships of the Rotterdam Lloyds line so-called Postal Agents were appointed from the 7th January 1904. The functions of these Postal Agents were the handling of on-board posted mail and the preparation of mail for posting in the ports of call, preferably in ports where ships could take the mail to the addressed destinations. This letter relates to the postal service of the ship 'Dempo'. There are similar known postmarks of ships or vessels of the "Stoomvaart Maatschappij Nederland" of the Amsterdam-Batavia line. There are many different postmarks in different shapes and forms.

The route of this letter is as follows. It was posted on board the 'Dempo'. In Egypt it was posted in port and flown KLM to Amsterdam and then by train to Luik in Belgium.

Can anyone clarify the status of the Savoy Hotel postmark Type HSY2? From the Hotel study papers and drawings, I am totally convinced that it exists but find that not only do I not have a copy of it, but nor does anyone else I know. There may well have been confusion in the recording, so I would like anyone who has one to send me a photocopy (or better still, the original) for study and clarification of the record. The differences between HSY1 and HSY2 are detailed below.

Comment: Eriksson's date for the Mena House Hotel stands as the earliest recorded. It would be interesting to know whether his example has a T before the duty. The subtype without T is recorded 7 III 92 to 20 IV 92; the strike with T is known from 7 III 92 to 25 II 95. (Unfortunately Eriksson's example is insufficiently clear to answer the question - Editor).

The Cataract is also deserving of an update. It is now recorded in four subtypes - with and without T and in blue and black. If there is no T in the blue example reported the latest recorded date is 2 III 14; with a T in blue the latest record is ? XII 15.

## Booklets of the Fuad Portrait Issue
